You are responsible for ALL waste disposal within your space.

A 6’0” table & 2 chairs are provided. You need to provide your own display materials. You are responsible to remove ALL products and waste from within your space at the end of the market. Nothing is to be left behind.

A 6’0” table & 2 chairs are provided. You need to provide your own display materials. You are responsible to remove ALL products and waste from within your space at the end of the market. Nothing is to be left behind.
